THE CHALLENGE

Critical access hospitals (CAHs) are facing unique challenges as they attempt to rebound post-pandemic, forcing them to rethink priorities to maintain the standard of care in rural populations.¹ There are several problems that continue to test CAHs, including workforce shortages, financial challenges, and clinical efficiencies.

THE GREAT RESIGNATION IN RURAL SETTINGS

Staffing shortages may be an industry-wide crisis, but the impact of understaffing is felt most severely by CAHs. There are 20 fewer physicians per 10,000 people in rural hospitals than in urban.² Similarly, a recent report found that severe staffing shortages forced 36% of CAHs to close their doors to new patients.³

Among the reasons for challenging recruitment in rural settings, staff can more easily maintain their clinical skills in urban settings.⁴⁻⁶ With limited new hires available, CAH leadership must find alternative ways to maintain high-quality care while alleviating the clinical burden on existing staff.

FINANCIAL CHALLENGES

Payment and financial performance are among the many obstacles facing CAHs and their patients. An analysis done prior to COVID-19 on the financial viability of U.S. rural hospitals showed that 354 hospitals across 40 states were at high risk of closing, and any downfall in the economy will likely worsen these crises for CAHs.¹ Even after the Medicaid expansion, CAHs are still at a financial disadvantage when compared to their urban peers. One study found that rural hospital operating margins were nearly 3.5 times lower than urban hospitals.⁷

The capital needs of a CAH are numerous and range from replacement of infrastructure items to technology enhancements for the delivery of care. Many CAHs struggle with an aging infrastructure and fail to meet minimum needs for operation. If a CAH wishes to sustain its operation over time, access to capital is crucial.⁸

CLINICAL EFFICIENCIES

The creation of the CAH designation in 1997 provided hospitals with financial security through cost-based reimbursement to assure access to quality healthcare for people living in rural areas. Over 25 years later, challenges remain for CAHs as they attempt to resolve systematic barriers that hold them back from achieving equitable quality standards with their larger, urban counterparts.

The use of technology in rural communities can have a significant impact on clinical outcomes, but CAHs often lack the financial capital and access to the personnel needed to install and systems.9,10 effectively maintain complex Although the presence of electronic medical records (EMR) may not have a direct impact on clinical outcomes at CAHs, the differences in their availability at CAHs compared to non-CAHs cannot be ignored. In addition, CAHs are even slower in reaching meaningful use after implementation of the EMRs, which implies that the full value of the tool is not yet attained.11 Additionally, the usage of telemedicine has shown to have important applications in underserved areas. 12-15 The paradox is that CAHs are the most likely to benefit from telemedicine, but the least likely to have it.16 Policy makers may need to consider additional strategies to avoid exacerbating an already emerging digital divide.¹⁷
